| A completed contract and the booking fee must be received to reserve the date and time of the Officiate for our ceremony. The non-refundable booking fee reserves our date and time. The booking fee is applied toward the total cost for services. The balance of the fee is due thirty (30) days prior to the ceremony dates unless all parties have agreed upon other arrangements. I understand that if booking fees and/or final payments are not received by the due date, my ceremony will be cancelled and the booking fee will not be refunded. For any booking fee or payment that is dishonored by our financial institution for any reason, we agree that there is an additional charge of \$50.00. |
| Officiate agrees to arrive at the ceremony address or location listed on the contract at least 30 minutes prior to any ceremony to insure compliance with his/her overall schedule. Couple understands that they must adhere to these times but they may be extended at Officiates sole discretion if Officiates schedule permits. |
| I also understand that it is my responsibility to acquire a valid marriage license in the state where the wedding ceremony will take place and that the marriage license must be on the premises when the ceremony is performed. I understand that failure to have these legal documents means that Rev. Shannon M.
